Both the student and the parent are required to submit processed 2021 Federal tax information. (Note: if the student or parent filed an <u>amended</u> 2021 IRS tax return, please call our office.) **The only acceptable methods to submit Federal tax information are:** 

#### 2021 Federal 1040 Tax Return:

Sign and submit federal tax return along with all schedules and W-2's. OR

#### **IRS Data Retrieval Tool:**

Directly import 2021 IRS data into your FAFSA: Log into <a href="www.fafsa.gov">www.fafsa.gov</a>, select <a href="Make Correction">Make Correction</a>. Choose 2023-24 FAFSA.

Click on <a href="Financial Information">Financial Information</a> tab. Select <a href="Already Completed">Already Completed</a> from drop down box. Enter Parent FSA ID and click on <a href="Link to IRS">Link to IRS</a>.

Continue to IRS.gov site. Enter Info as requested and submit. Click on box under "<a href="Transfer My Tax Information">Transfer My Tax Information</a> into the FAFSA." Then click <a href="Transfer Now">Transfer Now</a>. Transferred data will be encrypted. Remember to electronically sign and <a href="Submit">Submit</a> the FAFSA again. <a href="OR">OR</a>

## **IRS Tax Return Transcript:**

Submit your 2021 Tax Return Transcript. Go to <a href="www.irs.gov">www.irs.gov</a>. Click on "Get Your Tax Record," then click "Get Transcript Online" or "Get Transcript by Mail." Create an account. Select <a href="mailto:Tax Return Transcript">Tax Return Transcript</a> for 2020. Mail or email PDF to the LaGrange College Financial Aid Office. Please remember to put the student's name and student ID on the transcript.

## If you did not file a 2021 federal tax return:

Parents are required to submit proof of non-filing from the IRS if a 2021 tax return was not filed. Follow the same instructions as transcript above, but select "Verification of Non-filing Letter" instead of tax return transcript. If you are an independent student on the FAFSA who is not required to file a federal tax return, you must obtain a verification of non-filing status letter.
