2021 Federal 1040 Tax Return:

Sign and submit a copy of your 2021 Federal Tax Return along with all schedules and W-2 forms. OR

IRS Data Retrieval Tool:

Directly import 2021 IRS data into your FAFSA: Log into <u>www.fafsa.gov</u>, select <u>Make Correction</u>. Choose 2023-24 FAFSA. Click on <u>Financial Information</u> tab. Select <u>Already Completed</u> from drop down box. Enter Parent FSA ID and click on <u>Link to IRS</u>. Continue to IRS.gov site. Enter Info as requested and submit. Click on box under "<u>Transfer My Tax Information into the FAFSA</u>." Then click <u>Transfer Now</u>. Transferred data will be encrypted. Remember to electronically sign and <u>submit</u> the FAFSA again. **OR**

IRS Tax Return Transcript:

Submit your 2021 Tax Return Transcript. Go to <u>www.irs.gov</u>. Click on "Get Your Tax Record," then click "<u>Get Transcript Online</u>" or "<u>Get Transcript by Mail</u>." Create an account. Select <u>Tax Return Transcript</u> for 2021. Mail or email PDF to the address below.

If you did not file a 2021 federal tax return:

If you are an independent student on the FAFSA who is not required to file a federal 2021 tax return, you must obtain a verification of non-filing status letter from the IRS. Follow the same instructions as transcript above, but select "Verification of Non-filing Letter" instead of tax return transcript.
