

### **Policies and Procedures**

The LaGrange College Title IX Coordinator oversees the centralized review, investigation, and resolution of sexual misconduct reports and ensures compliance with federal guidelines and college policies. Sexual misconduct includes sex discrimination, sexual harassment, sexual assault, domestic violence, dating/ intimate partner violence, and stalking. Contact the Title IX Coordinator with questions or concerns regarding the college's sexual misconduct policy, violence prevention strategies, and resources for support.

## WHAT ARE YOUR RIGHTS?

### You have the right to request confidentiality.

If you file a report and want to request confidentiality, you can talk with the Title IX Coordinator, who may consult the appropriate college officer and make a decision based on available information.

### You have the right to contact the police.

You also have the right to decline to notify the local police or Campus Security. The college will not contact law enforcement unless requested or a threat of imminent danger exists.

You have the right to notice of, and access to, available services, including support services, information, referrals, medical assistance, and sexual assault advocates.

### You have the right to request interim actions to protect yourself and the broader LaGrange College community.

For an individual who believes they have experienced sexual violence, the college will take interim action and provide protective measures if requested and reasonably available. The college may take such steps even when an individual asks that the college keep confidential a reported violation of this policy and that it not investigate the matter and regardless of whether an individual chooses to report to law enforcement.

### WHAT TO DO IF YOU EXPERIENCE SEXUAL VIOLENCE

1. Get safe

### 4. Report the Violence

Reporting the violence does not commit you to filing a complaint with the college or filing charges with the police, though you are encouraged to do so. You can make a report to the Title IX Coordinator, Deputy Title IX Coordinators, or Campus Security. College employees who are not confidential resources, when made aware of incidents of sexual violence, have a responsibility to report the incident to the Title IX Coordinator.
