Dear LC Students:

This message is to inform/remind you of <u>college policy that requires you to take action</u> if you are enrolled as an <u>undergraduate, day student for the Fall 2021</u> semester. The policy was created to help the college better manage residential space and keep up with our students living off campus. To make sure that you understand how this policy applies to you, <u>READ the section below</u> that describes your expected designation in Fall 2021 and then <u>TAKE the appropriate action</u> based on your designation.

A full copy of the college's policies pertaining to the room hold assessment (page 91) and residency requirement (pages 88-93) can be found in the <u>2020-2021 Student Handbook</u>

Again, the Office of Campus Life is committed to providing a safe environment that supports student learning both inside and outside the classroom. I. I will be returning in Fall 2021, will enroll in 12+ hours [required to live in college housing] (Not a Graduate or Evening College student)

- <u>Students taking 12+ hours during Fall 2021 [required to live in college housing]</u> are required to pay a <u>\$200</u>
 <u>residential room hold assessment to participate in the housing lottery</u> (room selection process for 2021 -2022).
 This room hold assessment permits the college to reserve your space for Fall 2021. If you return to campus for the Fall 2021 semester, this \$200 is credited back to your student account (depending on account balance, etc.) More information on the housing lottery will be sent when it gets closer to the date.
- You must pay your \$200 assessment to the Business Office located on the second floor of Banks Hall before 5PM on March 15, 2021, to participate in the housing lottery. Save your receipt for the \$200 payment and bring it to the housing lottery as your proof of payment of the room hold assessment. No student will be able to hold a spot in a college residence hall until this assessment is paid (i.e., your friends cannot sign you up with them in the housing lottery). If extraordinary circumstances exist that would affect your ability to pay this assessment, please fill out the Deposit Waiver Request Form HERE.
- If you fail to pay your \$200 assessment or have not received a financial hardship waiver before 5 PM on March 15, 2021, a hold will be placed on your account that will not permit you to register for classes and/or receive a transcript. In addition to hold placed on your account for late payment/late approval, you will pick housing AFTER the students that have paid their \$200 assessment or have received a financial hardship waiver before the deadline of <u>5 PM on March 15, 2021</u>.
- The <u>\$200 fee can be paid online</u>. If you go to the college's website <u>https://www.lagrange.edu/current-</u> <u>students/business-office/index.html</u>> Click on "Submit Payment" under "Housing Lottery Hold Deposit – Returning Students" to complete the online payment option; make sure that you have your L number (student ID #).

II. I will be returning in the Fall 2021 and plan to live off campus (Not a Graduate or Evening College student)

- As you are aware, the college has a residency policy requiring that all students must live on campus unless they request and receive written permission to live off campus from the Office of Campus Life. The specific justifications for living off campus can be found on the <u>Residency Appeal Form</u>. Each student currently approved to live off campus, is required to submit an appeal form each year before 5PM on <u>March 15, 2021</u>. Students who submit their appeal form and receive permission to live off campus will not be required to pay a \$200 room hold assessment.
- If you fail to submit your request and do not receive written permission to live off campus before 5 PM on March 15, 2020, a hold will be placed on your account that will not permit you to register for classes and/or receive a transcript. Students who are suspected of attempting to manipulate the college's residency requirement or housing policies (i.e., listing that you will be living with a parent, when you are actually



living in an apartment or providing false information about your living address) may be subject to disciplinary action as well as the assessment of a full semester's room and board.

III. I will not be a full-time student (i.e., taking under 12 hours) in the Fall 2021 semester (Not a Graduate or Evening College student)

- Part-time students are not required to live on campus or pay the \$200 room hold assessment.
- Please know that, should you start the Fall 2021 semester under 12 hours and then add a class(es) to place you at/or above 12 hours academic hours (i.e., moving you from a part-time to full-time student status), you will be required to either live on campus or receive permission to live off campus; you are required to provide immediate notification of your change from a part-time to full-time student status to housing@lagrange.edu. Students who are suspected of attempting to manipulate the college's residency requirement or housing policies may be subject to disciplinary action as well as the assessment of a full semester's room and board.

IV. I will not be returning to LaGrange College (transferring, etc.) for the Fall 2021 semester

(Not a Graduate or Evening College student)

- Students enrolled during the Spring 2021 semester and <u>NOT returning for the Fall 2021 semester need to email the Associate Dean of Campus Life, at housing@lagrange.edu before 5 PM on March 15 2021.</u> In your email, share that you are not returning and include your: first name, middle initial, last name, and L #; you will be held from the housing lottery and you will not be required to pay the \$200 room hold assessment. Since you are not returning, a "not returning" hold will be placed on your account to signify that you will not return to the college, however, you be able to still request transcripts from the Registrar's Office.
- If you change your mind and decide to return for the Fall 2021, you will be required to pay the \$200 room hold assessment to be assigned a room in the Fall 2021 semester or request to receive written permission to live off campus. Please review the applicable areas above, if you decide to return for the Fall 2021 semester.

V. I will be a Graduate Student or Evening College student in the Fall 2021 semester

Graduate Students and Evening College students are not subject to the college's residency requirement, and you are not required to provide any information to the Office of Campus Life. If you are a Graduate Student or Evening College student who is interested in living on campus, please contact the Associate Dean of Campus Life at housing@lagrange.edu to discuss possible options.
